

- 聯交所、證監會及任何其他法定監管機關、政 府部門、行政機構或法院或其他法例、規則或 法規要求者;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師、獨立財務顧問或註冊證券商等。

# 4. 保留個人資料




